A quorum was declared by the Chairman and the meeting was called to order.

Mr. Don Templeton advised the Corporation members that the notice of the meeting had been posted at the entrance of the office of the Educational Enhancement Funding Corporation on September 14, 2015. A copy of that notice is on file at the Authority's office.

The Chairman asked for consideration of the minutes for the June 11, 2015 meeting. Mr. Karels moved to approve the minutes as presented, seconded by Mr. Hajek. All members present voted aye. Motion carried.

ELECTION OF OFFICERS

Mr. Templeton reviewed the Vice-Chairman and Secretary offices. Mr. Doug Hajek was nominated for Vice-Chairman and Mr. D.J. Mertens was nominated for Secretary. Mr. Karels made a motion to elect these two officers and Mr. Breckenridge seconded the motion. All members present voted aye. Motion carried.

MSA PAYMENT SUMMARY

Mr. Don Templeton reviewed the receipt of the MSA payments of \$23,420,999 that were received in April 2015. After funding debt service and operating expenses a transfer of \$5,520,853 was sent to the Education Enhancement Trust Fund held by the South Dakota Investment Council. The outstanding bonds, year to date financials and operating budget were reviewed in detail.

PERKINS COIE CONTRACT

Mr. Bruce Bonjour reviewed the Perkins Coie contract on file with the Educational Enhancement Funding Corporation for the period of September 1, 2015 through August 31, 2016 with the annual fee not to exceed \$15,000 for the legal fees plus \$1,250 - \$1,750 per each rebate computation prepared by Wildan Financial. Mr. Zellmer moved to approve the contract, seconded by Mr. Hajek. Jim Breckenridge, Tom Graham, Doug Hajek, D.J. Mertens, Dennis Neugebauer, Ken Karels and Steve Zellmer voted aye. Nays: none and abstains: none. Motion carried.

POST ISSUANCE COMPLIANCE REVIEW

Mr. Todd Meierhenry gave a post issuance compliance review summary and stated that the Educational Enhancement Funding Corporation was in compliance of bond covenants and federal law.
